

Section XI Appendix D-11 Existing Partnership Agreements

YSI BASEBALL/SOFTBALL FIELD USE AGREEMENT 2004

The Youth Sports Incorporated has two primary user groups, which have reached an agreement to lease the baseball/softball facility. Those two groups are the Douglas County Amateur Baseball Association and the City of Lawrence Parks & Recreation department. These two groups have been designated as having equal usage of the baseball/softball facility operated and scheduled by Y.S.I.

The Douglas County Amateur Baseball Assoc. has priority to Schedule the Y.S.I complex, and use a minimum of 3.5 days per week. DCABA may schedule a maximum of 7 days per week in the absence of a request for use by an outside users group, from April 1st to May 1st.

DCABA has the entire use of the Y.S.I. baseball/softball facility from the first of May of each year to the beginning of the Lawrence Parks & Recreation baseball/softball program. Once the season begins for the Lawrence Parks & Recreation department both DCABA & LPRD will have 3.5 days per week to schedule it's necessary games &/or practices. Specific days will be worked out between the individuals in charge of each respective program. If either group does not need the use of a field(s) at any given time between May 1st and August 1st, the other group shall have first priority for the use of that/those unused field(s).

The Y.S.I. management board has designated the <u>Spring season</u> as dates between March 1^{st} and April 30^{th} .

Summer season as dates between May 1st and August 1st, Fall season as dates between August 2nd and November 1st. The Lawrence Parks & Recreation Department shall have the entire use of the Y.S.I. baseball/softball complex beginning the third Monday of July through the first Saturday of August.

Both programs shall turn in its playing schedules to the Y.S.I. management board no later than ten days prior to the beginning of its regular summer season. Any unused playing dates are to be returned to the Y.S.I. management board or the person in charge of scheduling the facility. Those dates not used are available for any other user group or individual for a rental fee (determined by the Y.S.I. management board). At no time can either primary user group subcontract out their playing dates without the approval of the Y.S.I. management board.

A contract developed by the Y.S.I. management board must be filled out and signed by the person who will be responsible for the user group. Outside user groups must also provide proof of insurance prior to the use of the facility. All money generated from outside user groups renal fees will be divided equally between the Lawrence Parks & Recreation department and the Douglas County Amateur Baseball Association.

The Y.S.I. management board will designate someone who will be responsible for scheduling the baseball/softball complex. This person will keep record of field use and payment by each group that uses the Y.S.I. facility.

The Youth Sports Management board will review the above agreement annually.

FIELD USAGE FOR 2004

Douglas County Amateur Baseball Association:

*Douglas County Amateur Baseball Association has the use of <u>all</u> the Y.S.I. baseball fields from March 1st to April 30th. A minimum of 3.5 days per week for practice with a maximum of 7 days per week in the absence of a request for use by a outside user group.

*May 1st to May 16th, 2004 - ALL fields Monday through Sunday for games or practices. *May 17th through July 4th, 2004 - Fields #1 & #2 Tuesday, Thursday, Saturday (5pm to close). Field #3 Monday, Wednesday, Friday (5pm to close). Fields #1,#2,#3,#4 on Sundays (1pm to close).

Lawrence Parks & Recreation:

*Lawrence Parks & Recreation has the use of the designated Y.S.I. baseball/softball fields from May 17th through July 4th, 2004- Fields #1,#2,#4 Monday, Wednesday, Friday (5pm to close) + Saturday (9am to 5pm).

Fields #3, #4 Tuesday, Thursday, Saturday (5pm to close) + Saturday (9am to 5pm). *Beginning July 5th, 2004 the Lawrence Parks & Recreation has use of <u>all</u> the fields through the 1st Saturday of August.

For the year 2004 the cost for the use of the Y.S.I. baseball/softball facility will be determined by the YSI management team and split in half between the Douglas County Amateur Baseball Association and the Lawrence Parks & Recreation Department. Payment will be adjusted for each user group pending the use of the facility by and outside organization. Money generated during the previous year through rental to outside user groups will carry over to the next year's budget to possibly lower the coast of use by the primary user groups.

Douglas County Amateur Baseball has agreed to pay a minimum of \$5,000.00 prior to May 1st, 2004 with the balance being paid by May 31st, 2004, or when requested by the Y.S.I. management board.

The Lawrence Parks & Recreation Department has agreed to make full payment by May 31st, 2004 or when requested by the Y.S.I. management board.
