Subject: Sales Tax Distribution

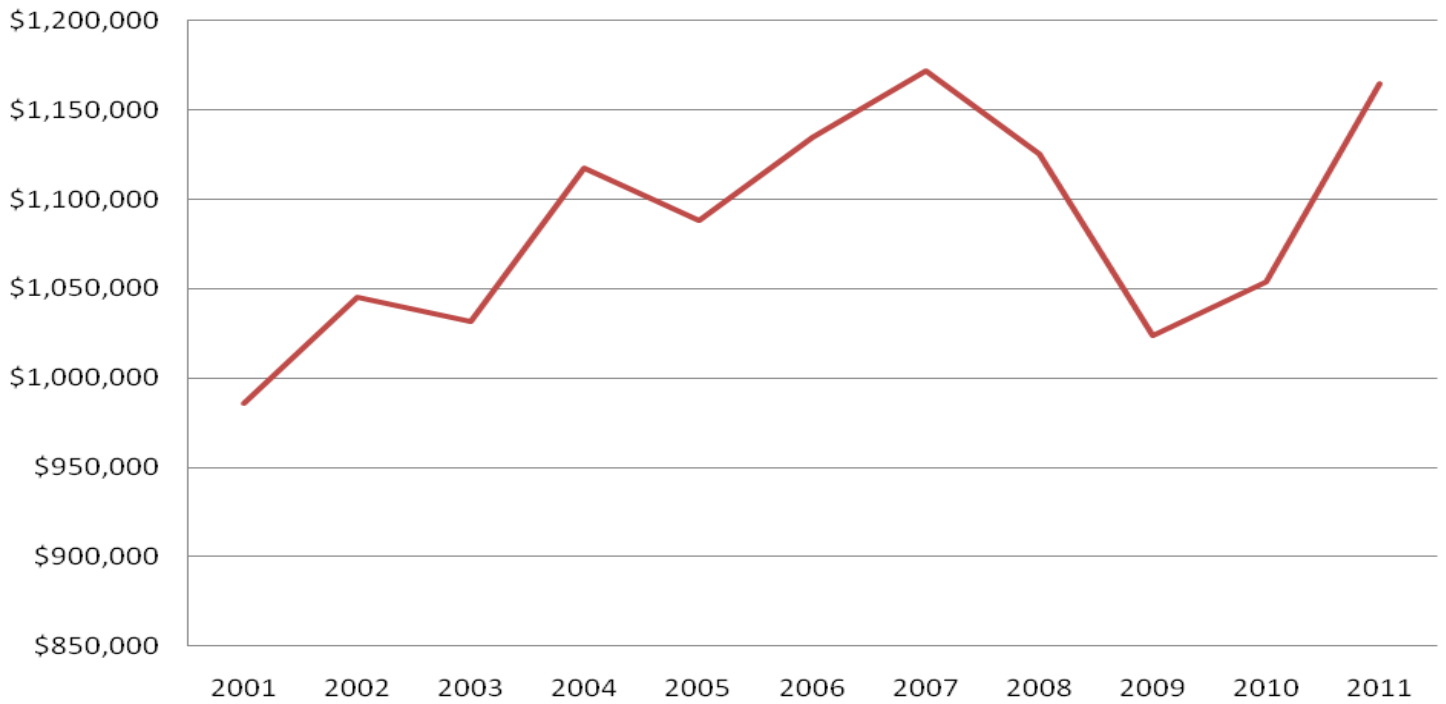
The City of Lawrence has recently received its February sales tax distribution. The distribution is the result of retail sales from mid-December to mid-January. The distribution of \$2,767,211 is \$219,000 more than the prior year distribution for the same month. It also includes \$3,148 from the Free State Transportation Development District and \$11,395 from the Oread District. The distribution also includes additional amounts that will be paid to the Oread Tax Increment Financing District.

A projection of current year sales tax revenue will be made at the end of the first quarter. However, for 2011 sales taxes to equal the budget, sales tax distributions will need to increase by 2.0% over 2010 revenue. A summary of the latest city sales/use tax distribution is shown in the table below.

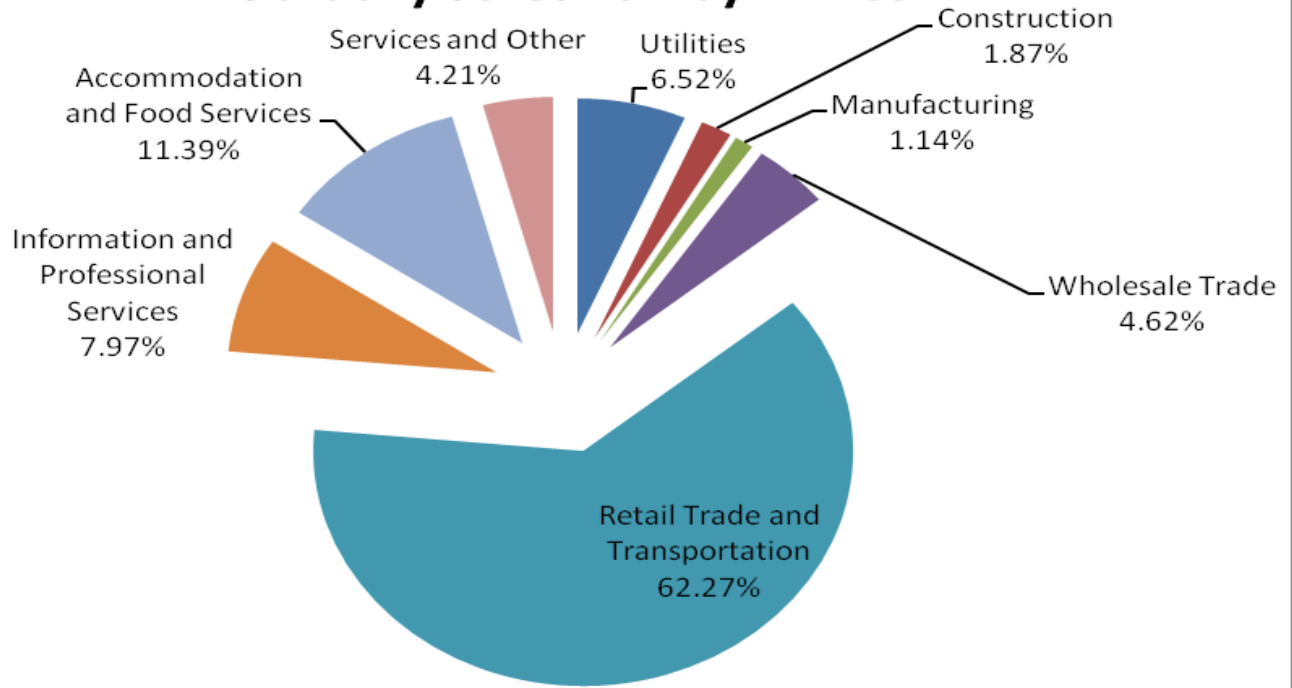
February 1% City Sales Tax
