RE: May 2022 Sales and Use Tax Report

The City received its May sales and use taxes, along with its share of County sales and use tax, and the special taxing districts distribution, which totaled \$4,267,288. This is predominately from sales that occurred in March 2022. Of this amount, \$3,507,564 was from sales taxes and \$723,964 was from use taxes before Tax Increment Financing Districts (TIF) payments were applied. The remaining \$35,761 was from sales and use taxes within the three Transportation Development Districts (TDD).

May Sales and Use Tax

Sales and Use Tax Budget Comparison (excluding special districts)

Sales and use tax for May 2022 compared to budget:

The City's sales taxes experienced a \$185,163 increase (8.03%).

The City's use taxes experienced a \$97,568 increase (24.58%).

The City's portion of the County's general sales and use tax experienced a \$114,971 increase (10.30%).

Sales and use tax for Jan. – May 2022 compared to budget:

The City's sales taxes experienced a \$353,192 increase (3.12%).

The City's use taxes experienced a \$459,471 increase (23.55%).

The City's portion of the County's general sales and use tax experienced a \$307,665 increase (5.61%).

Year-to-date total sales and use tax revenues experienced a \$1,120,328 increase (5.97%) compared to the budget.

Sales and Use Tax Trends Year to date

Sales and use tax for May 2022 compared to prior year:

The City's sales taxes experienced a \$111,481 increase (4.67%).

The City's use taxes experienced a \$97,948 increase (24.70%).

The City's portion of the County's general sales and use tax experienced a \$91,376 increase (7.98%).

Sales and use tax for Jan. - May 2022 compared to prior year:

The City's sales taxes experienced a \$1,102,833 increase (10.37%).

The City's use taxes experienced a \$611,143 increase (33.97%).

The City's portion of the County's general sales and use tax experienced a \$675,502 increase (13.12%).

Year-to-date total sales and use tax revenues (including special districts) experienced a \$2,405,162 increase (13.54%) compared to the prior year.



Given the City's reliance on sales tax, and the significant impact that COVID-19 has had on sales in the City, we felt a little deeper analysis of where we are in relation to where we have been, and where we believe we are headed would be beneficial.


This chart has been modified to include FY's 2018-2021 and our actual results and current projection for FY 2022. As you can see from the chart, our sales and use tax is higher than we projected, by 6.31%.

As the chart illustrates for May:

- FY 2020 collections were \$16.63 million.
- FY 2021 collections were \$17.59 million. 5.78% growth over the prior year.
- FY 2022 collections are \$19.98 million. 13.59% growth over the prior year.



This chart shows month over month change for FY's 2017-2021, and our actual results for FY 2022. The City has had growth in monthly sales tax collection for the past fifteen months.



Sales Tax Distribution

Sales within the City are from a wide variety of industries. The largest industrial segment is Retail trade at around 59% of all sales (Noted in the table below in blue).




The following table is divided by the North American Industry Classification System (NAICS) sectors to provide some context to the diversity within the City's sales tax system. Retail Trade has been broken out below, so the top four categories are listed separately. The table shows that there was growth in all but one significant categories in Retail Trade compared to last year. There was also growth in nine of the other significant categories. Overall total sales were up by \$1,102,833 or 10.37% when compared to last year.

Use Tax Distribution

Use taxes within the City are from a wide variety of industries. The largest industrial segment is Retail trade at around 69% of all use taxes (Noted in the table below in blue).



The following table is divided by the North American Classification System (NAICS) Industry Sectors to provide some context to the diversity within the City's sales tax system. Retail Trade has been broken out below, so the top eight categories are listed separately. The table shows that there was growth in all but one category in Retail Trade when compared to last year. There was also growth in six of the other significant categories when compared to last year. Overall total use taxes were up by \$611,143 or 33.97% when compared to last year.
