Receive informational presentation about a potential Common Consumption Area Downtown

Executive Summary

With KU football being played in Kansas City this season and as part of the City's Unmistakable Identity outcome area, the City Commission asked staff to work with stakeholders to look into a Common Consumption Area (CCA) for Downtown Lawrence.

Kansas legislation permits municipalities to create <u>Common Consumption Areas (CCAs)</u> in designated districts, where individuals can consume alcoholic beverages outside of licensed establishments on delineated city property. These beverages must be purchased from licensed establishments within or adjacent to the CCA. Local governments are responsible for setting their own rules within state guidelines, and these regulations are typically codified by municipal ordinance.

A Common Consumption Area does not allow individuals to bring their own alcoholic beverages into the district for consumption, rather, beverages must be purchased at an establishment with permission by the State of Kansas to sell alcoholic liquor, that are within or adjacent to the established Common Consumption Area, who have elected to participate in the Common Consumption Area.

Staff worked with a stakeholder committee and held five public meetings at the Carnegie Building for business owners and operators to learn more about Common Consumption Areas (CCA) and to share their feedback and concerns. Common Consumption Area community engagement web page.

Background

Kansas legislation (Chapter 41. Intoxicating Liquors and Beverages § 41-2659) permits municipalities to create Common Consumption Areas (CCAs) in designated districts, where individuals can consume alcoholic beverages outside of licensed establishments on specific city properties.



With KU football being played in Kansas City this year and, as part of the City's Unmistakable Identity outcome, the City Commission asked staff and stakeholders to look into a Common Consumption Area (CCA) for Downtown Lawrence.



Staff held preliminary meetings with representatives from the City Clerk's Office, the City Attorney's Office, the Lawrence Police Department, Parks, Recreation, Arts and Culture, the Parking division, The Chamber, the Lawrence Restaurant Association, Downtown Lawrence Inc., and explore Lawrence.



Staff also held five stakeholder-public engagement meetings that included 40 representatives from 32 downtown and nearby businesses. (Business list, last page)



Background



A Common Consumption Area or CCA is established locally by Ordinance and includes applicable local rules and regulations.



Participation in a CCA is *voluntary* for businesses within its boundaries. To join, businesses must have a valid on-premise License or a temporary permit if located within a CCA and they must apply to the State of Kansas ABC for approval.



Individuals are *not* allowed to bring their own alcoholic beverages into a CCA for consumption nor are they allowed to take alcoholic beverages out of a CCA.








- Definition: A CCA is a specific zone where individuals can openly carry and consume alcohol from licensed participating bars and restaurants.
- Legal Framework: Established under Kansas state law and overseen by KS ABC, CCAs are created to enhance public enjoyment and economic activity in designated areas.
- Location: CCAs are typically found in downtown districts, entertainment zones, or special event spaces.
- Regulations: Alcoholic beverages must be purchased from licensed vendors within the CCA. Bringing alcohol from outside or taking it out of the CCA is prohibited.
- Identification: CCAs are clearly marked with signs and pavement markers to inform the public of the boundaries.
- Hours of Operation: CCAs operate during specific hours established by the municipality and included in the ordinance.
- Security and Safety: Increased security measures, such as police patrols, are sometimes implemented to ensure safety and compliance.
- Benefits: CCAs aim to boost local businesses, attract tourists, and create a lively community atmosphere.

How a CCA works




1. Common Consumption Area (CCA) boundaries established and marked



2. Licensed establishment(s) in the CCA opt-in by applying to ABC



3. CCA member businesses serve in disposable cups w/ their logo



4. Customers can walk with beverage in cup within the CCA (Nonparticipating CCA businesses can determine if customers can enter with beverages)



5. Customer finishes drink and disposes cup before leaving the CCA

Example of signs marking the boundaries of the CCA
















Time of CCA

- Have clearly set times ideally consistent daily
- Example Thursdays through Saturdays, 4 to 10 p.m.
- Or, perhaps during select event times
- Either way, be consistent

Exclusions

- Parking lots and garages should not be included in the CCA
- City Parks should not be included in the CCA

Trash/Sustainability


- Disposable cups will likely generate more trash downtown how to handle and additional staff cost for clean up
 - Special receptacles?
- Sustainability issue plastic cups, compostable cups or other?
 Stipulated by Ordinance?

Security

- Strict enforcement is necessary from the start
- Coordinated patrol by police at start of program
- Are signs necessary?
- Can signs be removed when the CCA is not in operation?








Benefits


- Increased activity downtown
- Increased alcohol sales
- Table notification apps people can walk with a drink while they're waiting for a table or after they eat
- Shopping and window shopping before and after a meal
- Possible special sale options during CCA?



Wants and Concerns

- Downtown is already perceived as unsafe, concern this will exacerbate that perception
- Unsure if this will benefit retail over restaurant or vice versa
- Keep property owners and businesses from having to be enforcers
- Limited restroom access downtown now
- Continue allowing sponsored events within CCA (e.g. Free State and Busker Festival in permit area)
 - Maybe need to "close" CCA during event?
- Authorize local agency to monitor and make decisions.
- Are there other family-friendly program options that might be more beneficial?
