## Safe Winter Walkways Program Seeking Volunteers

We are having great snows this winter!

Do you have a neighbor who needs your help?

Able bodied Lawrence residents with a flair for helping others and an enjoyment of winter weather are needed to volunteer for the "Safe Winter Walkways" program. In order to create safer and more accessible pedestrian walkways, the City of Lawrence has joined with Douglas County Senior Services to match residents needing assistance with snow removal with volunteers who want to do a neighborly good deed.

There is online registration for this project. Volunteers will be asked to commit to the entire winter season and visit his or her matched home each time snow falls. "This program is an excellent resource for members of our community who physically can't keep their sidewalks clear during snow events," said Megan Gilliland, communications manager for the city. "This program is a structured version of what has happened in neighborhoods for many years, neighbors helping neighbors. With volunteers, we can make certain that the neighbors can count on a volunteer to be there if snow needs to be removed."

## More Ways to Get Help With Utilities

- *Turn It On!* offers utility assistance through ECKAN and Trinity Lutheran Church to help households whose utilities have already been shut off only. Contact ECKAN at 841-3357 to find out about assistance. Donations are gratefully accepted for this program. Contact ECKAN or Trinity Lutheran (12th & New Hampshire, 843-4150) to donate.
- Warm Hearts offers up to \$300 for heating assistance. Applications are available at Salvation Army, ECKAN, Ballard Center and Penn House. For more info: www.warmheartsofdouglascounty.com/index.shtml.
   Tax deductible donations are accepted for this program.
- Project Deserve helps pay the Westar Energy electric bills of people with a severe disability (children or adults meeting Social Security disability criteria) and older adults (people 60 years or older). Also, eligible households may receive one-time annual payments of up to \$100 to be applied toward their Westar Energy electric bills. The American Red Cross determines eligibility based on household income. Contact the Douglas County American Red Cross Chapter, 785-843-3550.

## **Assistance Available for Home Energy Costs**

If you need help with your energy bills this winter, the State of Kansas has funds to help. The Low Income Energy Assistance Program (LIEAP) is a federally funded program that helps eligible households pay a portion of their home energy costs by providing a **one-time per year benefit**, that is sent directly to your energy provider. Any remaining portions of your bill must be paid by you.

Applications for assistance must be made between January 19 – March 31, 2010. There are both income and family guidelines that must be met in order to receive assistance. You may apply for this program only during the open application period. Call or visit your local SRS office during this time period to find out if you are eligible or to apply.



### **ELNA Helps Restore the Neighborhood**

Have you seen the house at 1120 Rhode Island lately? Part of the North Rhode Island Street National Historic District, the house is fully restored and ready to be moved into. This project was the dream of ELNA, the Lawrence Preservation Alliance (LPA) and Tenants to Homeowners (TTH). There was an open house on Dec. 5th – our own Janet Good spoke about the work and dedication it took to keep this property from becoming a parking lot. Dennis Brown reminded us that preserving history is not only about the preservation of the lives of the rich, but also of the working class. This house is a historical reminder of the mixed income neighborhood that East Lawrence has always been and remains as today. TTH is planning to build 5 additional affordable housing units in the adjacent open lots.



ELNA members added their own sweat equity to the restoration project at 1120 Rhode Island. The group above was part of a crew that dug up and then re-laid the brick sidewalk in front of the house. Thanks to Mike Meyers, John Myers, Phil Collison, KT Walsh, Josh Davis, Peter Szabo, Heather Coates, marci francisco and Joe Bickford for all the hard work.

## Happenings at the Train Depot

The City Commission voted in December to cautiously move ahead with the project by seeking only half of the total cost of preserving the depot. Visit www.depotredux.org to see a conceptual drawing of what the hopes are for the depot. It features some new parking east of the train station and an expansive garden to the west. If Lawrence is awarded the Transportation Enhancement grant from KDOT this June, unfortunately beautification such as this garden and parking upgrades will not be on the list to receive funding. They are not critical. A new roof, upgraded heating and cooling and ADA compliant doors and bathrooms will be part of this first phase of the depot's preservation. It will be two more years before the City can apply for TE funding to help pay for the cost of the remaining work.

Depot Redux would like to extend its deep appreciation to the ELNA members who donated time to clean and participate in preparation of the Historic Structures report prepared by Hernly Associates. Also, a huge thanks to East Lawrence neighbor, Linda Wright, daughter of artist Helen Garret whose painting of the 1883 depot was given as a gift to the depot at the December 6th holiday gathering. The painting was found at an antique store in Ottawa and was cleaned and reframed. Linda was present at the gathering to speak about her mother's career as a Lawrence artist.

### **Home Energy Efficiency Improvement Tax Credits**

Consumers who purchase and install specific products, such as energy-efficient windows, insulation, doors, roofs, and heating and cooling equipment in existing homes can receive a tax credit for 30% of the cost, up to \$1,500, for improve-

ments "placed in service" starting January 1, 2009, through December 31, 2010. See EnergyStar.gov's <u>Federal Tax Credits for Energy Efficiency</u> for a complete summary of energy efficiency tax credits available to consumers.
