March Minutes: KT moves with corrections, Josh 2nds, unanimous

Affordable Housing: Robert Baker came to tell us more about inclusionary zoning. He also shared that Leslie is starting an affordable housing coalition. What is inclusionary housing? PowerPoint (see attached) handed out from an innovative housing institute in FL. Government funding for affordable housing is being sequestered, so other methods are needed to ensure that it survives. How it's done and enforced is dependent on the municipalities. Shortage of affordable housing unless you have a Section 8 voucher, but these are also being restricted. We've lost 72 tax credit units since 2012, due in part to Westgate Apartments going out of business. His research has shown that tax credit housing is at nearly 100% (98.6%) with available units going down. Good examples to follow are Cambridge, MA for how to deal with this problem, they required that 12% of housing be affordable or pay the cost for that housing. Over 20 years they claim over 2000 units of affordable housing have been created. Density has to be controlled for, but it could happen here based on density on either end of EL. Other models exist that can be used as a basis for brainstorming. What can we do? A real broad based coalition needs to be formed. See article from Journal World stating that we are most expensive neighborhood (Loghorn, 4/29). May need to redefine our criteria of diverse neighborhood. Write a plan in order to make it a campaign issue. Anyone interested is encouraged to contact Leslie Soden to become a part of the Affordable Housing Coalition. John says that the city claims that you can go to the Horizon 20/20 page and find an email to give feedback to. Susan Tate added the importance of affordable housing as well as workplace came up over and over again during the cultural arts district meetings.

Arts Center Update re: Free State Film Fest, Ben Ahlvers. Festival will happen June 25-29. Been going on for 4 years now, has grown into multifaceted event. Received grant to help with that growth and it includes film, art, music and ideas. Outreach has occurred as part of the grant with VanGo and their films will be shown on Friday night. Art compontent-Granada to Bowerstock will have temporary projections on the buildings, as well as down 9th street (between CT and NY), NY school will also be involved all the way down to the Warehouse district. Performance based events will occur as well. Ideas component being led by KU primarily. Kicks off on 25th with doc on Johnny Winter and performance by him as well. Grant is for 2 years so it will likely be happening again. Complex, immense and exciting project. Coincides with the tour of Lawrence bike race. Waiting to hear back about ArtPlace grant in June.

Fundraising: Committee met and created list of potential ideas for raising funds. Refresher-we're about \$3000 short of the CDBG funds so we need to get some cash. Ideas from meeting include: round up at registers, east side calendar, more advertising on merch, more KVKL concessions, tables at Food Truck

on merch, more KVKL concessions, tables at Food Truck festival and HCHC, east Lawrence business tab on website.

River "Adopt a Park" Program: Mike Myers looked into the Adopt-A-Park program for our riverfront park. City provides bags, organization must do clean up at least 4x/year. Christine motions for Mike to move forward with program, KT seconds, vote unanimous.

Maddie Hinds, Habitat for Humanity Community Outreach Coordinator: Habitat builds safe, decent and affordable housing for families living between 30-60% median poverty. Have built 85 houses in Lawrence, 86th will be at 1233 New Jersey for a single mom with 3 kids, one with special needs. They currently live in Eudora, but kids go to school and mom works here. Families must pay for their houses, mortgage is 0 interest. Majority of labor is provided by volunteers. Habitat Restore is also big funding mechanism for salary, rent. In kind donations are also accepted, as well as land donations. Board and committees are volunteer based. Here to request support to welcome family to the neighborhood and the workers. Volunteer, bring food/drinks for builders, whatever! \$20k needed to get started. Goal is to get started by July. Build 9-3, T/Th/Sat. ELNA can include write up in newsletter. Energy star approved in order to keep utilities manageable as well as the mortgage. Families must put in 225 hours of sweat equity into the home, or another home being built.

Budget:

NYE site plan update-

Jay Holly from Gould Evans presented update on construction and reviewed plans for New York Elementary.

*Historic school stays, portables leave.

*Additions will be added for kindergarten, art, special education and dining.

*Existing parking lot (teacher lot) will be moved to New Jersey Street.

*Play surface-basketball hoops, play sets, and smoothed out grass field will be on the north.

Arts Place Grant update-

Susan Tate & Bob Shumm came to give update on grant.

*Background: In December 2012 City Commission voted to start an arts district. 9th street was identified as an important part of this to tie downtown to this district by recommendations of the Cultural Distract Task Force. The city is currently in the process of hiring a Director of Arts and Culture, a city positions, as well as creating a cultural plan, city wide. Lawrence was just awarded grant by the KS Dept. of Commerce providing money for walkable, well-lit sidewalks beginning with 9th street corridor.

*Lawrence Arts Center received a grant from the National Endowment of the Arts for Creative Place Making, working with art and culture to bring people together. This \$500,000 can be used

as leverage with the city and state government to further recommendations made by the Cultural District Task Force and to make 9th street a complete street.

*Next steps-By September 2014, a RFQ (Request for Qualifications) will be sent out to designers/architect plus civil engineers who have experience working specifically with artists. Those people hired will answer to the new Director of Arts and Culture. Over the next 10 months that team will meet with stakeholders. Street financing will come from the city-will likely cost about \$3million, which city already knew, especially with all the building happening on the west end of it. Will be dug up from Mass to Delaware. Concerns: parking, gentrification, an arts neighborhood where an artist can't afford to live, traffic calming measures, lighting (want dark nights), can neighborhood have input on who gets hired to do the work, timing is tricky due to projects along 9th street that are already underway, maybe have sustainability advisory board included in the street plans to help with water runoff, any chance of using imminent domain to widen the street, keep as much of the workers/artists local.

The Courthouse Lawn

Fifty years ago, there were over a dozen homes adjacent to the old Douglas County courthouse, and East Lawrence, along New Hampshire and Rhode Island - that aren't there today. One of these dwellings, located at 23 East 11th Street, was razed by order of the Board of Commissioners forty-five years ago this May. Once a prosperous neighborhood settled during territorial days, was now located within the contiguous footprint of a proposed city-county facility expansion project launched in 1963. Fourteen years of ensuing machinations (the project was never approved, and was singularly rejected by voters by a margin of 5-3) erected this cheaply-appointed pillbox, using Nixon-era revenue sharing dollars. The Judicial and Law Enforcement Center, 111 East 11th Street, finally opened for business on November 1st, 1976.

The County had acquired the frame house at 23 East 11th (it was in the eastern portion of the green space between the two county buildings) in 1965 for \$13,000. Described as vacant in the 1966 Polk Lawrence City Directory; that year's January 19th issue of the Lawrence Daily Journal-World ran a photo of the local Jaycee's accepting the keys to the house from the Lawrence Board of Realtors, through an accommodation made with the County. The local civic organization stretched its \$5,000 in cash by

marshaling volunteer labor and materials to remodel the dwelling, a stone's throw from the old Douglas County Courthouse. On April 7th, 1967, Achievement Place, Inc., a home for boys from unfortunate backgrounds, accepted its first charge. The project was initiated at the suggestion of Judge Charles Rankin during his second of nine consecutive terms (1957-1975), when he began calling for alternative facilities to handle youngsters in trouble.

From this humble grass-roots legacy, Lawrence Achievement Place would become a much studied and emulated institution. From Mt. Oread, 'Mont' Montrose Madison Wolf (1935–2004), professor of Human Development and Family Life at KU, as a research associate with the Bureau of Child Research (1965-2000), directed federally funded studies at Achievement Place for twenty years, perfecting what was to become a national model for pre-juvenile community-based group homes. This humane alternative to the state reformatory system of the turn of the 20th century was replicated hundreds of times. The Journal of Applied Behavior Analysis (2005, Summer) in a posthumous retrospective, cited professor Wolf's Teaching-Family Model, and his founding association, as having trained and certified an estimated 10,000 teaching parents, who attended to over 85,000 youngsters worldwide

Achievement Place had lost its county lease and was looking for a new home, when at 4:22 p.m. on Wednesday, April 16th, 1969, a gas explosion in the basement ripped the house off its foundations. Deemed uninhabitable, the county moved quickly to raze the then half-century-old house.

Following the blast, Achievement Place relocated to the land-mark Congressman Dudley Haskell home at 1320 Haskell Avenue. Haskell was famous for 'bringing home the bacon,' with the development of the federally-financed American Indian facility of 1884, which bore his name.

The Lawrence Coalition for Peace and Justice has awarded ELNA's own KT Walsh this year's Tom and Anne Moore Peace and Justice Award for an individual. KT Walsh uses her considerable talent in art to further peace and justice issues in all of Lawrence. As a board member of ELNA, she champions its "live and let live" culture. A steadfast attendee at weekly City Commission Meetings she speaks up for safe sidewalks, street lighting and vernacular architecture. She keeps a vigilant and benevolent eye on our community. Thanks in large part to her efforts, the Marriott hotel being built at 9th and New Hampshire will be shorter by one story. This will allow more light and a less obstructed view for its neighbors, making it a better design for the community it abuts.

A thirty-year Lawrence resident, KT Walsh volunteered and then managed the Social Service League for seven years. And with flair! She recycled blue jeans to insulate its unheated back room. She inaugurated the "dress for success" program so job seekers could appear for interviews in decent suits and shoes. More recently, KT Walsh was a co-founder of the Percolator, a generator of artistic expression for peace and justice issues.

It is especially fitting to recognize KT Walsh this year because of her contribution to the Lawrence Community Shelter (LCS). She led residents and guests in making a mural, one with inspirational quotations, in the dining room. She is now painting a mural designed to fit a semitrailer truck, (approximately 25 feet long). The mural will be hung on the outside of a semi on the premises of at the Lawrence Community Shelter. The images are those brainstormed by LCS clients. First, the dangers of homelessness—trains, poison ivy, drugs and alcohol. Next, the promise of the LCS—computer training, comfy-looking bunk beds, and fresh food. And finally, success independence symbolized by an eagle, a cyclist, and a dog running free.

Because she has so well used her art for the benefit of Lawrence's neediest citizens, KT Walsh is a worthy recipient of the LCPJ's Anne and Tom Moore Award.


Prayer and Action Program – A Note from St John's and the Kansas City Archdiocese

Riverfront Conservation Park Adopted By ELNA!

At the June 2nd ELNA meeting it was announced that ELNA has officially adopted the Riverfront Conservation Area through the City of Lawrence Parks and Recreation Department's "Adopt-a-Park" program. The program encourages clean, beautiful parks and builds community through mutual stewardship of our natural assets. The Parks and Recreation Department will provide free trash bags and latex gloves as well as the pick-up and haul-off of the debris collected.

It is typical for a park to be cleaned three or four times per year by the adopting agency. Since our riverfront area has quite dense vegetation we have scheduled two of the cleanup days during months when there are few leaves on the trees and the vegetation is down. The dates chosen for the following year are: November 15th 2014, March 14th 2015, and June 13th 2015. Cleanup days will always start at 8:00 am and end at noon.

The reason for adopting this particular park is that we think our beautiful Kaw Riverfront is one of our top neighborhood assets and one that we don't get the chance to enjoy as much as we should. The area is protected habitat and cannot be developed thanks to the hard work many of our neighbors at a time when commercial construction on the riverfront was eminent. Due to the nature of the conservation easement there has not been much enforcement of city laws including camping and littering. As a consequence the area gets fairly thick with litter.

Please put the dates noted above on your calendar and plan to come support this effort to be better stewards of one of our most precious neighborhood assets. These cleanup days are an excellent way to get out in nature, get exercise, provide a valuable service, meet your neighbors, and build community. More information will follow closer to each cleanup day. We typically have some coffee and snacks to fortify us before we begin.

The agenda for July is packed with updates on new developments happening in East Lawrence. Central to the neighborhood is the renovation and expansion of New York Elementary school. We'll have a chance to see how the final site plan makes better use of the school yard. Moving on East a new development at 9th & Delaware will help define the



residential edge along Delaware street. Dubbed 9 Del Lofts, the building will house multiple residential units, and has plans to integrate the very likely Burroughs creek trail expansion.

At the July meeting, we'll get to see the site plans for those two developments, and begin our discussion with the Lawrence Arts Center who is slated to have already received the Art's Place Grant to re-envision 9th street.

For better or worse, East Lawrence is under-going a process of place making. Dis-belonging, in our case, is most likely through gentrification and will lead to displacement and segregation, and that's not good for our neighbors and our neighborhood.

As our neighborhood garners attention, wanted or not, we need to participate in the process and keep it authentic. The process itself ought to strengthen us in an equal and open way. Please consider attending the upcoming meeting, and add your voice to the conversation.

City Home Improvement Assistance Programs

The City of Lawrence offers several grant and loan programs for income eligible homeowners, through Community Development Block Grant funds; Comprehensive Housing Rehabilitation, Emergency & Furnace Loans, and Weatherization Grants.

The Comprehensive Housing Rehabilitation program provides deferred or installment loans to income-eligible homeowners to borrow up to \$25,000 to have necessary rehabilitation completed. This is not a remodeling program. Work is performed by pre-qualified general contractors and may include the following: roofing, windows, paint, electrical, plumbing, flooring, foundation repairs, replacement of certain fixtures and appliances. Participants in the program who are 62 and older, will make no monthly payments as long as they remain the owner-occupant. Other participants will make \$50 monthly payments. Up to 50% of these loans balances may be forgiven over a 7 year period.

The program has funding to complete approximately 10 projects a year, so it is not unusual for applicants to wait several months for the project to begin. Properties that have already participated in the program are ineligible.

For emergency situations, the City offers the Emergency and Furnace Loans program. This program can provide up to \$5,000 for emergency repairs or furnace replacement. Mobile home owners may access up to \$2,500. These loans have no monthly payments but are payable when the participant is no longer the owner-occupant of the property. This the only program that is available for Mobile Homes. Mobile homeowners may access up to \$2,500 to make the necessary improvements.

The Weatherization program is a grant program for homeowners and does not need to be repaid. Work includes attic insulation, storm windows and weatherstripping of entry doors. Applications are accepted during the month of August each year, with the majority of work being finished by January. Properties that have participated in the program since January 1, 1993 are ineligible.

More detailed information on each program, eligibility guidelines, applications, and application deadlines for

Tea House on the Courthouse Lawn

In January, 1905, without pomp or pageantry, county officers began moving into the new courthouse on the southeast corner of 11th & Massachusetts Street. Three years later a residence for the Sheriff's family was completed next door, fronting 11th Street. Tucked behind this dwelling, obscured from public view by design, was the County Jail. Appropriately, these local governmental institutions were organically inserted into a residential block with a mature arbor canopy.

Sheriff Fred Vogler enjoyed the neighborhood so much that upon leaving office in 1939, he and wife Helen purchased the house a few yards to the east. Prof. Frank O. Marvin had owned this dwelling since the 1860s and sold it to physician Alfred Gifford on June 25th, 1890, the year before being named Dean of KU's School of Engineering. Dr. Gifford and his wife Grace lavishly remodeled the building into a modern ten-room home at the turn-of-the-century.

Two weeks after V-J Day, marking the end of WWII, the property changed hands (Sept. 17, 1945). Seventeen East Eleventh Street, having maintained its beauty for four decades, bid adieu to its residential owner, to become a commercial property. The new proprietors deemed the bustling location to be a perfect fit for the intersection of commerce and everyday life. In the fall of 1945, Sadie and William McGrew, following a quick refurbishment, opened "The Hearth," a Tea Room.

Mrs. McGrew had years of experience in tea room management in the southeast Kansas cities of Chanute, Parsons and Pittsburg. The McGrew's had settled in Lawrence in 1942, after a five year stint running the tea room and banquet hall at the Kansas City, Kansas *Hotel Grund*. Miss Nellie Reese Evans branded "The Hearth" in the fall of 1937, within the rooms of the Lawrence Women's Club at 1941 Massachusetts Street. That next autumn, first lady Eleanor Roosevelt attended a luncheon at "The Hearth" ahead of her evening speech to 2,500 people at Hoch Auditorium, entitled "The Responsibility of an Individual to His Community."

The McGrew's took over the management of "The Hearth" from the retiring Miss Evans. The expiration of the lease with the Woman's Club occasioned the McGrew's move of the Tea Room to E. 11th Street, practically on the courthouse lawn.

Tea Rooms, around since the 1880's, became extremely popular with women in the first decades of the 20th

century. When single income households still held sway, autos ushered in a new independence for the homemaker to motor forth to a ladies luncheon. Usually, as was the case in Lawrence, the tea room was opened in a former residence, catering to an all-female clientele, by offering domestic familiarity and the allure of home cooking. Tea rooms served as a social gathering place and venue of choice for club meetings, often devoted to advancing progressive civic ventures.

Dennis Domer, Professor Emeritus at the University of Kansas and author of a 2008 local historic register listing survey of East Lawrence, has expressed the view that the Women's Clubs of Lawrence were "really influential and way out ahead of the men's clubs when it came to interest in design and city building. The women really were the first to recognize the importance of the downtown and worked to save it before the men caught on."

The McGrew's daughter Editha was living in California when she sold the tea house property to Douglas County on June 15th, 1964. The County Board of Commissioners moved swiftly to raze the old home. The wrecking ball felled the County Jail shortly after the opening of the sterile, modular Judicial and Law Enforcement Center along East 11th Street, on November 1st, 1976.

City Comprehensive Plan Update Meetings and Online Survey

In 1991, Lawrence, and unincorporated Douglas County endeavored to create a comprehensive plan to guide land use, growth and development, management and preservation of historic and natural resources, and infrastructure needs. The resulting guidelines became known as Horizon 2020.

At that time, Lawrence had a little more than 65,000 residents, and covered approximately 5% of County lands. According to 2013 statistics, the City's population nears the 90,000 mark and has twice the geographical footprint. It has become clear, that though Horizon 2020 remains a solid guiding foundation, it is time update some key elements to reflect the needs and challenges of contemporary Lawrencians and Douglas County residents.

In order to conscientiously inform the Horizon 2020 updates, Douglas County and the City of Lawrence have begun a "comprehensive plan update process." This process includes a Steering Committee, public Open House meetings, and both selectively mailed paper surveys, and an online survey. The Steering Committee is an advisory board composed of 10 members who meet each month at City Hall. The Committee's primary task is to directly oversee the process of changing Horizon 2020 and to prioritize issues to be brought to review by other City entities. Public Open House meetings were held throughout April, May, and June. You are invited to attend the next meeting July 18th from 6-8pm at the Dreher Building in the Douglas County Fairgrounds. Special surveys were mailed to random households in May, and another survey open to all residents is available at the City website http:// www.lawrenceks.org/2020survey.The online survey focuses on key issues including the character of Lawrence and Douglas County, expectations for growth, and prioritization of issues related to residential development. Please take the H2020 Survey and let City officials know what you'd like to see included as part of comprehensive plan revisions. The online survey will be available until August 1.
