Item #1: Neighborhood Contact Information

Item #2: Horizon 2020 Update Process -

The City and County commissions adopted a joint resolution setting up a steering committee to oversee and guide the review process. There will be an extensive public input period where comments are gathered from all stakeholders, including the public, advisory boards, neighborhood groups, and others that will last through the fall of 2014.

The Horizon 2020 <u>Steering Committee</u> would like to invite you to the visioning process for the update to the <u>City/County Comprehensive Plan</u>. Your focus and knowledge are invaluable to helping us create a guide for the continued growth and development or our community. The open house survey period ended August 1st and staff presented results of the survey to the Steering Committee at their August 25th meeting. Other presenters will also be presenting on various topics throughout the next couple of months. The Steering Committee will be hosting two public forums on various topics in November. The forums will be held from 6-8pm November 5th and November 13th at the Lawrence High School cafeteria. Item #3: Additional Rental Licensing & Inspection Program Seminars Scheduled in November

During November 2014, the City of Lawrence Planning & Development Services Department is hosting two more educational seminars to assist property owners, property managers, tenants and the public with the transition to the recently revised and expanded Rental Licensing and Inspection Program. Current single-family zoned rental properties were affected by the changes starting July 1, 2014. All other rental units in Lawrence will become part of the Rental Licensing and Inspection Program beginning January 1, 2015. Three similar seminars were conducted in May and June 2014, and were well attended and constructive.

The City's goal is to make this a smooth transition by answering questions regarding the regulations and logistics of the new Program during the seminars. City staff will review the initial licensing, license renewal and inspections processes, and provide plenty of time for a question and answer session.

The seminars will be held on the following dates/times:

The Community Development Advisory Committee has two openings for appointments to the committee. The open positions are for low-moderate income area representatives. The appointees must come from an area that is 51% or more low-mod and is not already geographically represented on the committee. Item #8: Market Match Information for Neighborhood Associations

Market Match is in full swing at area farmers' market. Market Match is a dollar for dollar matching program that matches SNAP benefits (food stamps) spent at the farmers' markets. The program provides matching funds up to \$25 per day. For example, a family that spends \$25 of their SNAP benefits would receive \$50 in market tokens to use at the various vendor booths. Market Match makes it easier to buy fresh, healthy produce while supporting local producers at the same time.

Z-14-00369: Consider a request to rezone approximately 1.1 acres from RSO (Single-Dwelling Residential-Office) District to RM24 (Multi-Dwelling Residential) District located at 345 Florida St. Submitted by Grob Engineering Services LLC on behalf of DCCCA Inc., property owner of record.

Z-14-00300: Consider a request to rezone approximately 0.8 acres from RSO (Single-Dwelling Residential-Office) District to CN2 (Neighborhood Commercial Center) District, located at 4101 W 6th St. Submitted by Doug and Berniece Garber, property owners of record.
