

### Neighborhood Update for LAN April 2011

## Item #1: Community Development Advisory Committee Public Hearing

Members of the Community Development Advisory Committee will conduct a public hearing on the 2011 Action Plan of the 2008-2012 Consolidated Plan, including the 2011 Investment Summary, and a Substantial Amendment to the 2008-2012 Consolidated Plan, on Thursday, April 14, 2011 at 6:00 P.M. in the City Commission Room, First Floor, City Hall, 6 East 6<sup>th</sup> Street.

During the public hearing, the Advisory Committee will seek input regarding the 2011 Action Plan and 2011 Investment Summary. The Action Plan and Consolidated Plan is required by the Cranston-Gonzalez National Affordable Housing Act of 1990 and is the result of a collaborative process whereby a community establishes a unified vision for community development using federal, state, and local funds. In addition, comment can be made regarding the proposed Substantial Amendment to adjust the proposed Specific Housing Objectives Accomplishment Goals for the five year period, August 1, 2008 – July 31, 2012.

The draft Action Plan and Investment Summary will be available April 7, 2011 on the department web site at <a href="https://www.lawrenceks.org/pds">www.lawrenceks.org/pds</a>. The Consolidated Plan is currently located on the City of Lawrence website at <a href="https://www.lawrenceks.org/pds">www.lawrenceks.org/pds</a> under "Reports and Plans". The public comment period for both items will be thirty (30) days from the date of the public hearing, until May 14, 2011.
