- 1. <u>Text Amendment to Remove the Requirement that Projects be Consistent with Horizon 2020</u> The City Commission denied this request at their April 23rd meeting.
- Oread Design Guidelines Staff is working on the draft document and will soon begin
 meeting the appointed PC and HRC members to review. A joint meeting with the PC and HRC
 will occur this spring to introduce the draft to both commissions before public hearings on the
 rezonings (guidelines) and text amendments.
- 3. <u>Downtown Redevelopment Issues Memo</u> The HRC and PC are meeting to discuss the recommendations outlined in the report at the regular meeting of the Historic Recourses Commission on Thursday, June 20th at 6:30 pm in the City Commission Room at City Hall.
- 4. The True Value of Trees: How our rural and urban forests benefit Douglas County Results of the 2012 Douglas County Forest Assessment provided by David Nowak with the USDA Forest Service. Thursday, May 9th 6:30 PM to 7:30 pm, Helen Dreher Building at the DG County Fairgrounds, 2110 Harper Street, Lawrence. Findings from this assessment can help create a better understanding of our area forest and the services and values it provides. Local leaders, planners, and residents can use the study results to develop improved long-term management plans and policies that will protect and preserve our trees for future generations.
