Ted spoke with our City commissioner's, Jeremy Farmer and Nancy Thellman, along with our Mayor Mike Dever about the Deleware tribes plans with the land. Talk has taken place of a casino in Leavenworth Kansas again. There has also been discussion of the Deleware selling a portion of their land here in Lawrence and keeping the 30 acres with the house on that portion. The tribe may turn the house into their tribal office. The City of Lawrence would like to make a trade with them and will bring up a proposal at a later date. This team literally goes above and beyond to make sure their plant works together as a "team" pushing forward to improve any issue that may arise by ways of what they call, Human & Organizational program/performance A.K.A., HOP. 
