Board Present: Ted (President), Jeff (Vice President), Beverly (Treasurer), and Dylan (Coordinator)

President's Report:

President thanked everyone for coming. There is some information on the upcoming sales tax vote available. It's a three part vote, so you can vote for each of them independently. The new Maple street pump station was constructed from the first iteration of this sales tax infrastructure fund. This pump has proved itself recently with the large amount of rain we had in the previous months. Each part of the vote has the percentage and what it will go to – Transit, infrastructure, and affordable housing. It will sunset in ten years if it is reapproved. This tax, if passed, could help benefit North Lawrence as there are many improvements that could be done with this money. We will give the candidates an opportunity a chance to talk about themselves and then open it up to everyone for questions.

Rod (Peace Mennonite Church member): Coordinating committee wanted to update the neighborhood about the plans for the building. The idea is to expand the building with a new sanctuary being in the North, as well as other various updates to the building. Some coordination will be needed, but NLIA will be able to keep meeting in the space. The president thanked Peace Mennonite church for allowing us to use this space.

Public Comments:

The North Lawrence City Commission candidate forum was held.

Elections:

NLIA board member elections were held at the conclusion of the city commission candidate forum. A member made a motion to nominate all current board members (Ted- President, Jeff-VP, Beverly-Treasurer, Dylan-Coordinator/Secretary) for reelection. No other nominations were made, and the motions was put to an oral vote and passed with unanimous support.

NLIA Neighborhood Meeting Notes...

NLIA minutes — April (April 10, 2017 7:00pm to 8:30pm)

Board Present: Ted (President), Jeff (VP), Beverly (Treasurer), and Dylan (Coordinator)

President Report:

Saturday was KU Big Event and it seems a lot of people in N. Lawrence participated. I heard good things about the students that participated, and we always look forward to the event. There is an individual in N. Lawrence who wants to initiate the placement of a welcome to N. Lawrence sign. They are going to draw up what the sign would look like, and we will look and see if this is something that N. Lawrence and NLIA would want. We will talk about the cost and placement hopefully at the May meeting. If it is approved then NLIA will have to go before the city commission. The downtown grocery store is still in process, but it will be a Price Chopper with a 200 car parking garage. There was a new store that opened in Ottawa, and the design of the downtown store will be similar to the Ottawa store. The next step now is that it will be presented to the city planning commission, but the hope is by late summer or early fall they will be breaking ground. We are trying to reduce printing costs for the newsletters, and the CDBG funding may be reduced in the future. There is a possibility that the funding for NLIA could be eliminated or reduced in the future. So there may be a need to raise additional funds for operating expenses. The City of Lawrence Police Department will be at the May NLIA meeting. Please report incidents in

your neighborhoods as you see them. It helps the police to do their job properly, and it notifies them of where to patrol. Don't forget that the cleanup is next Tuesday April 18th, and limbs should be brought to the Centenary Methodists parking lot. Mulch will be ready after a few days and is available behind Ted's house (310 Elm) and is for use by all North Lawrence residents. There is no item size limit and tires can also be set out.

Guest Speaker(ICL & Chemtrade) Comments:

Gordon(ICL): Use the raw materials of phosphorus, phosphoric acid, and sodium carbonate. They use these chemicals for a variety of purposes. One of the primary uses for these chemicals is in processed food products. ICL has been investing in the Lawrence plant with 9 million being invested between 2014 and 2016. They have also begun increasing their energy efficiencies (Decreasing their use of electricity, water, and natural gas). ICL is planning on continuing their capital investment in the Lawrence plant with 7 capital improvement products being planned for the future. ICL is very active in the community, and they have had a community advisory panel for 20+ years. They are also involved with Woodlawn, Junior Achievement, and United Way.

Shane(ICL): As many residents know the previous owners of plant/land had created their own on-site dump for the disposal of byproducts. These byproducts contained arsenic, which combined with the low water table and loamy soil transported the arsenic throughout the area. Currently there is no way to access the contaminated area, and no one is at risk. The problem was solved at the time by discontinuing dumping, and property owners downstream being put on city water. The threshold for arsenic dictated by the federal government is 10 parts per billion (ppb). The results of regular monitor indicate that arsenic concentrations remain stable, and the plume is consistent with previous results. Their current technique of immobilizing the arsenic using bio-stabilization has shown promising results, but more long term monitoring is required. ICL has a 40 acre nature area, and will try to get a controlled burn soon. There is a one mile walking trail to the South of the plant that is open to the public.

Drew (Chemtrade): Chemtrade produces a variety of chemical products, such as acids, sulfur products, sodium nitrate, P₂S₅. P₂S₅ is what is produced at the Lawrence plant, and is primarily used as an engine oil additive. The Lawrence plant has approximately 30 employees.

Public Comments:

Resident asked about the historic North wall at the current Borders building being a concern when that store was first constructed.

Ted: The historic wall will be saved. It has always been the plan for the wall to be preserved in the construction of the new store.

Resident: Asked if the plant produces any smells.

ICL is primarily producing steam that is released through the stack. Chemtrade does occasionally deal with Sulfur, which can produce a smell at times but have not had any issues recently.

Resident: Asked what possible accidents are capable at each of the plant?

Chemtrade & ICL: The biggest hazard at the plant has to deal with fire, smoke, and the gas it produces if the chemical comes in contact. The smoke that is produced from the fire is phosphoric acid in air, but it is acute in nature. Whoever inhales it will feel a burning sensation, but it is not toxic. If a fire event does occur then the best thing is to shelter in place at your home with all the windows and doors closed and the air conditioner off.

Vice President asked why the garage sale is after the cleanup since there is always left over items from the garage sale. President responded by saying that the weather is too unpredictable in the month of April.

NLIA Neighborhood Meeting Notes...

NLIA minutes — May (May 08, 2017 7:00pm to 8:00pm)

Board Present: Ted (President), Beverly (Treasurer), and Dylan (Coordinator)

President Report:

We will have a couple of guest speakers tonight. One representative is from the Lawrence Police Department (LPD), and a resident who will present about the sign. Ted met with Barry Queen of the Price Chopper that will hopefully be going in at the downtown location. He will be adding 140 employees if this store is built. Store will have a café and a 2nd story mezzanine. Mr. Queen stated that his store is very price competitive with only Wal-Mart having better prices on average. He gave Ted an update on the layout of the store, and he is currently just waiting on approvals from the city so the development group can start construction. The store will be going before the city for the necessary approvals soon. The North Lawrence clean-up had a few problems and Ted received the call from the city. The problem had to do with a resident leaving approximately 28 tires, and another resident had demolished a structure and placed it by the curb for pickup. Another person dumped brush and vines at the location for limb collection, and this material cannot be chipped and proved to be a problem. That is not what this neighborhood cleanup is designed for so there will have to be future discussion on the matter. The North Lawrence garage sale is coming up May 18 & 19. Ted has received calls from many surrounding communities wondering if the garage sale was still going on.

Guest Speaker - Lawrence Police Department (Chief Tarik):

The chief expressed that he would rather answer questions than relay his standard talking points. He answered a few questions. There has been ongoing discussion for a new police facility, and it cannot be funded in a short amount time without revenue increase through taxes. The police department just got done implementing their mental health officers. Ted asked the chief to talk about how all the patrol cars now have defibrillators, and they were paid for by the Lawrence Police Foundation. The chief said that he will be retiring in 6 weeks and the search is on for a replacement.

Guest Speaker - Don Benda:

Lived here for three years, and moved from Northwest Kansas. When he moved down here he looked for houses all over the city, and his son suggested that he look in North Lawrence. He ended up buying a house in the area. He expressed that North Lawrence residents have a lot of pride in their community. While riding his bike one day he wondered why there wasn't a sign designating that you were entering the community. His son is a graphic designer and created a great design for a sign. If NLIA and its members show interest then he will be going to a sign company to get a quote for cost. He said that since the sign is about community pride then it would be nice if it is entirely funded through community donations.

Public Comments:

Resident did bring to Ted's attention that their normal trash was not picked up on the cleanup day. Ted said that the resident should call him and he will contact the city to make sure items are picked up.

Resident asked if the newsletter included information as to what was an acceptable item for the spring clean-up. Ted said that yes there is usually a list.

The property owner of 401 Elm gave an update on the property at that location and said that the building was un-condemned in late January, and all the code violations were resolved in March. Now they will be working with the city to get the property rezoned for what it has historically been. Asked Ted for help and to meet with him to help navigate the zoning process with the city.

When should we call the police? You can call the LPD 24/7. However, 911 is reserved for emergencies but there is also a non-emergency number you can call (785-832-7509).

Resident had a friend in law enforcement and wondered if the attrition rate is because of the increased violence. The chief said that it is more of a phenomenon of media attention than of violence, however has been an increase in crimes targeting officers.

Resident asked if Lawrence was going to be implementing a program to help veterans or provide them with advantages for joining the LPD. The chief said that there have been and are many veterans, but the training and skillsets are different enough that both civilians and military should get all the training.

Resident expressed that she is glad and appreciative of seeing the officers around the community.

Ted presented the chief with a North Lawrence Sandrat T-shirt and license plate.

Notes from the President...

Well, another summer has come and gone. A lot of good things have happened in North Lawrence. The curbs and gutters on North 2nd street were redone for better drainage, and a new speed hump was installed on North street. Two more speed humps are planned to be installed at 7th and Elm St and 7th and Walnut St. NLIA will be writing a grant in the future to have two more installed in North Lawrence. The proposed locations for the two additional speed humps are 4th and Lincoln St, and 5th and Lincoln St. In addition to that, other improvements in the area include installing ADA sidewalk ramps at the intersection of 4th and Locust St, as well as sidewalk installations on Walnut St. The city has also stated that they will begin working on the ditches leading to the new pump station in the spring, which should help with ensuring proper drainage of storm water. The pump station itself has been doing a good job of clearing out stormwater from the area, but clearing the ditches should help even further. Perry St in the 400 and 500 blocks will be the first to have ditch work done. NLIA has been working hard for two years to ensure the proper completion of this project. There is still a lot more to be done for the area, but NLIA will keep on the city to complete future projects.
