LAWRENCE ASSOCIATION OF NEIGHBORHOODS REPORT – LINDA BUSH:

- Neighborhood associations have been asked to support a low-power radio station to broadcast programs of community interest, which will be volunteer-driven. LAN will support it, and forms will be submitted to individual neighborhood association to register approval. No financial commitment will be required.
- A text amendment to Horizon 20-20 (City development master plan) has been proposed creating an exception for certain development. City Planning Commission has rejected it. Motion carried that PNA submit a letter to the City Commission asking that the proposal be rejected. Pat Miller will prepare a draft.

OLD BUSINESS:

- Bus Stop Shelter at 4th and Maine: Discussion continued with no resolution.
- Bulk trash pickup event: Date has been changed since newsletter sent out; now, May 20.
- CDAC funding for 2013-14 discussed. No change in status for PNA.

NEW BUSINESS:

- Fund raising for 2013 discussed.
- Annual picnic (June) discussed. A subcommittee will be created, starting with a meeting at 345 Mississippi Street on 4/30/13 at 1:00 p.m. Solicitation for participation will be put out on face book and e-mail.
- Motion to have PNA treasurer obtain a tax ID number carried.

The meeting was adjourned at 12:00 p.m. Following the meeting Kirk McClure, Professor of Urban Planning at KU, gave a presentation about current development issues in Lawrence. The next scheduled meeting is May 18, 2013.

We will also continue our planning for events, projects and priorities for 2013. We won't draft you involuntarily into service, but we will ask your opinions and collect your ideas.

We'll have light refreshments and try to leave time for a little social visit following the business meeting. Please bring your thoughts and ideas about what PNA can do for you and your Pinckney neighbors as well as ideas on how you can join with others to make Pinckney an even better place to live.

Pinckney Tunnel Project

Pinckney students have been working for years on getting their tunnel some new lighting and artwork - and it's about to pay off! Next week, members of the Pinckney Tunnel Project will sign papers and hand over a check to Van Go Inc., then the design phase will begin. Members of the Old West Lawrence and Pinckney neighborhoods will meet with Van Go's amazing young artists to begin designing the 10 panels of mural art to be installed in the tunnel. We're also working with the city to improve lighting and drainage. Our supportive city partners are also taking care of sand blasting and painting the walls white - WHICH WILL REQUIRE A FEW DAYS OF TUNNEL CLOSURE! Please check the Pinckney Neighborhood Association website and Facebook pages for dates the tunnel will be closed, and please help spread word to any neighbors that rely on the tunnel. USD 497 No-Tax-Increase School Bond Meeting

On Monday, Feb. 4th, the Pinckney Elementary School library was standing room only while residents learned more about the school bond issue that will be put to a vote on April 2nd. Dr. Rick Doll, the USD 497 School District Superintendent, shared how the \$92.5M bond would be spent. The elementary schools would receive their long delayed repairs (\$80.3M), all schools will receive wireless technology (\$6.5M) the high schools will get a couple of changes to ensure equity between the two, and the rest will be used to build Lawrence's new vocational/technical training space. The new space will house health labs, construction science, computer networking, and machine design/technology labs, to develop a stronger work force for Lawrence. USD 497 will partner with local community colleges for these programs, and adult education can occur in the spaces at night.

For Pinckney Elementary School, the plans include \$6.9M worth of work, including desperately needed HVAC, electrical, and plumbing repairs, secure school entrances, safe drop off traffic flow, additional classrooms so children aren't taught in hallways and tiny make-shift offices, enlargement of 11 classrooms, and construction of a new gymnasium that is separate from the current cafeteria. This bond will mean that no matter where you live in Lawrence, students will have the same opportunity, technology, and space. All trailer classrooms will finally be eliminated as well.

The work will take about 3-4 years to complete, and the bond is a 20 year bond. Note, this is money that can only be used for infrastructure. Funding for teachers, staff and training can only come from the "General Fund", which is controlled by the Kansas Legislature, not locally. (\$10M has been cut from USD 497's General Fund in about 3 years.) A "NO" vote would result in taxes for a \$150,000 dollar home going down by \$8.53 per month; a "YES" vote would keep the tax rate steady and fund these important school improvements.
