Treasurer's Report

PNA will have \$2,467 in its checking account after reimbursables and will be receiving a \$5,476.50 CDBG grant. Due to the resignation of the PNA coordinator, there was \$1,722.48 unspent in this year's grant. *A motion was made to accept the Treasurer's report by Steve Braswell, 2nd by Melinda Toumi. Voice Vote. Motion carries.*

LAN Update

S. Braswell attended the LAN meeting. Of note:

- Chamber President Larry McElwain presented a new direction for The Chamber. Rather than spending most of its resources pursuing new companies, it will focus more on growing existing businesses and start-ups.

Business Items

- **Picnic.** It was a success! Approximately 75 people attended. We raised \$51.06 in cash; 76# of food. **K. Heck to write** thank you notes on behalf of PNA to Anderson Rentals, Fastlane, Checkers and Dillons. **P. Miller to write** a thank you to the anonymous donor for the music. For the future, we had 3 full packages of hot dogs leftover.
- **Pinckney Playground portion of Clinton Park to USD 497** - After further review of the proposed land transfer and discussions with the city and other parties including the Lawrence Preservation Alliance, PNA is pleased with the final rule, which will be brought to the City on Aug. 25. **M. Toumi** to represent PNA.
- **Coordinator.** The job description for the Communications Coordinator was reviewed and supported. PNA will pay \$300 /mo. (\$15.00 /hr. - dependent upon skill set) for an average of 20 hrs. of work/mo. It is desired that the coordinator know the neighborhood. The job description will be shared with LAN and through PNA's communication channels. (**P. Miller to distribute**). Desired hire date is Sept. 25 with an ideal start date of Oct. 1. A committee of S. Braswell, P. Liechti, K. Heck and P. Miller to review applications.
- **Trunk-or-Treat Oct. 24. B. Sufian** is chairperson and will begin organizing. Kids from OWL are welcome, however, we will not co-host it with OWL. **P. Miller to secure** the LMH parking lot. *A motion to make Health Care Access the charitable recipient was made by S. Braswell, 2nd by P. Liechti. Voice-voice. Motion carries.*
- **Elections.** Elections take place at the Feb. 2016 meeting. Vice President and Secretary are up for election. PNA residents are encouraged to run. PNA still needs a treasurer; anyone interested contact P. Miller.
- **Neighborhood Plan.** The process to develop a plan was briefly discussed. **P. Miller to ask** Scott McCullough about availability/timing for a city planner's involvement. Others to invite for assistance could include Charlie Bryan, Community Health Planner; Bonnie Johnson, KU; Lynne Zollner, Planning Dept. Historic Preservation.
- **Newsletter.** A newsletter will sent to the neighborhood in the next two weeks. Send items to P. Miller.

Treasurer's Report

There was no changes to the bank balance since the last report. During the meeting, a reimbursement for Pinckney materials to President Miller was approved and B. Sufian will witness. New CDBG grant has been received.

LAN Update

S. Braswell attended the LAN meeting. Of note:

- Housing lot sizes are being reduced from approx. 7,000 sq. ft. to approx. 5,000 sq. ft. by developers and drainage issues are of concern. Pinckney should consider addressing in the neighborhood plan and as well as sidewalks.
- The Downtown grocery store may become a reality in the old Borders location.
- Industry revenue bonds have been requested for the 8th & New Hampshire location re-construction; most likely as a means to avoid paying sales tax on materials.

Business Items

- **Coordinator.** The ad is on Facebook, Pinckney website, sent to LAN and is in the upcoming newsletter. Deadline to apply is Oct. 1. A committee of S. Braswell, L. Littlejohn, K. Heck and P. Miller to review applications.
- **Waterline Replacement Program.** Waterlines will be replaced in 5-phases on Michigan on both sides of 6th street and other streets in the neighborhood. The phased approach minimizes disruption since each phase is completed before the next phase begins. Street parking may be limited during working hours. Homeowners will be notified re: water outages. Major intersections will be addressed during the KU holiday break to take advantage of less traffic. Go online for more information (City of Lawrence rep Troy Shaw presented.)
- **Parks Clean up:** Oct. 3, 9:30 a.m. Parks include Burcham, Sandra Shaw, Clinton, Constant and Woody. **S. Braswell** to distribute bags to each park and to contact/remind the city. Choose your favorite park, wear gloves, stuff trash bags and leave them by the trash receptacles for Parks & Rec to pick up. Meet at Clinton at 11 a.m. post-cleanup. If it rains, we'll reschedule; if it is sprinkling the clean up is on.
- **Trunk-or-Treat Oct. 24. B. Sufian** is chairperson and has secured many, many sponsors and gift cards. Set up is at 3 p.m. Our social cause is Health Care Access. Go online to see what items they need. Sign up for to host a trunk is through sign up genie. Bus drivers will hand out fliers to students who ride the bus in the neighborhood. OWL kids are invited, too.
- **Neighborhood Plan.** Tabled until next meeting.

- The city's rental program is generating \$300,000 in annual fees; inspections are increasing and the program should attain break-even.

Go to the website for more information. 3) CDBG grant is due in December. **B. Sufian** volunteered to help **P. Miller** prepare it.
- **Pinckney Site Council:** Gould-Evans, the architects for the school have invited P. Miller to look at the new design of the school; construction will start next fall.
- **Downtown Grocery Store:** The development of a downtown grocery store may advance. There is a meeting Thurs., 9 a.m. if anyone is interested in attending. **L. Fahy** plans to attend.
- **KU Hire a Habitat:** Nov. 13. For a suggested donation of \$25 per hour for each volunteer, Lawrence residents can hire a KU student to do odd jobs. The funds raised go toward finding local families affordable housing.
- **E-Cycling event:** Oct. 24, 9 a.m. - 1 p.m. at KU's Park & Ride, Clinton Parkway & Crestline Drive.
- **Trail Development:** A paved trail is being built between Constant Park and Burcham Park and it will cause erosion. City Commission will be discussing potential changes to it at its next meeting. **P. Miller** will attend.
- **Trunk or Treat:** Oct. 24 Our fall event should be a great success -- details are nearly final. We still need face-painter, and may need a tumbling pad by the entrance to the bounce house.
- **Parks Cleanup:** It was a successful event! For future events, may want to invite the Boy Scouts or other organizations to assist. Stream and deep ditch clean-up is challenging.
- **Elections:** February elections are approaching. Spread the word that we need candidates for the Vice President and Secretary. The Treasurer's office is vacant and has one year remaining in the term.

The Coordinator's contract will begin as soon as possible and will be completed on July 31, 2016, which is the end of PNA's grant year. Renewal of the contract is possible following an annual evaluation to be conducted in June. If needed, the position will be advertised in July for the following grant year.

Position Summary: The Coordinator for the PNA is responsible for completion or coordination of communications and related responsibilities, including:

- coordinating and attending regular meetings
- filing quarterly PNA reports with the City of Lawrence
- planning for and coordinating yearly events
- preparing 4 to 6 newsletter or postcard mailings and monthly e-newsletters with news and notices affecting the neighborhood
- maintaining PNA email inbox and responding to emails, as directed by the PNA Board
- coordinating signage and advertising for PNA events
- other various tasks as assigned by the PNA Board

The Coordinator will be expected to take initiative, contribute ideas, and keep the PNA Board informed of the Coordinator's activities. The Coordinator must schedule time efficiently and work through objectives to meet goals and deadlines on time.

- Trunk-or-Treaters welcome from 4 to 6 p.m.

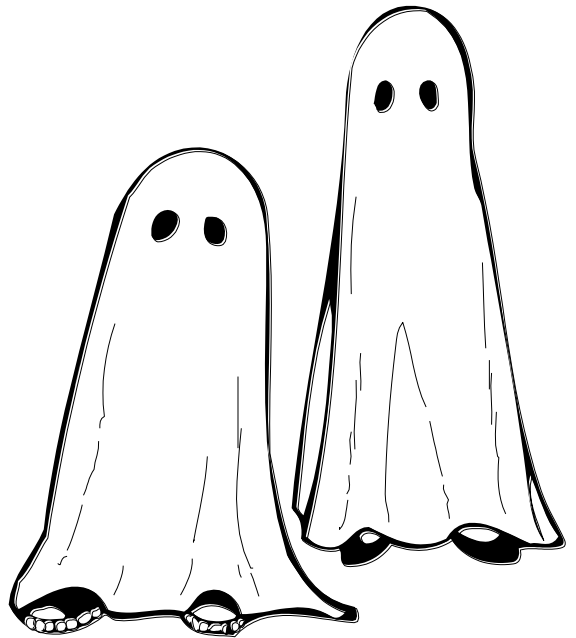
Admission? Free! We encourage you to bring donations for Health Care Access Clinic.
