

Your feedback helps shape decisions!

1. City's proposal to use Woody Park as a temporary homeless camp, starting November 2020.

The City has proposed using Woody Park, located within the Pinckney Neighborhood near LMH, as a temporary homeless camp. The camp would serve approximately 25 individuals beginning in Nov 2020 for a period of at least 2 months but no more than 5 months. This campsite would provide unsheltered homeless with access to a socially-distanced personal campsite with a tent, sleeping pallet, restrooms and showers, laundry facilities, secure storage lockers, and food in a managed environment. The area would be fenced to ensure resident safety and privacy. The City plans to hire a non-profit (TBD) to operate the campsite. Camp residents would be screened by the management partner to assess vulnerability (i.e., physical and mental health) and willingness to follow an established Code of Conduct. The management partner will provide 24/7 staffing of the site to ensure operations meet expectations. Funding to support this project will come from federal CARES Act dollars awarded to Douglas County by the State of Kansas.

2. City's Bus Route Survey

The City will engage with the community over the next 12 months to collaboratively determine a new route structure for bus transit. The scope of work for Route Redesign Study #1 can be found at www.lawrencetransit.org/transfer-facility.

3. For or against Accessory Dwelling Units (ADUs)?

Accessory Dwelling Units are small houses or apartments that exist on the same property lot as a single-family residence. The City is considering opening up more neighborhoods to allow ADUs. PNA needs to hear from YOU to see if this is something that our Neighborhood Association should adopt a stance on.

Eviction Moratorium Extended Through Dec 31st



On September 1, the Centers for Disease Control (CDC) announced it would issue an order to temporarily stop residential evictions nationwide for nonpayment of rent of qualifying tenants in response to concerns about the spread of COVID-19. The order took effect on September 4 and will remain in effect through December 31, 2020.

You must meet a five-pronged test to qualify for your eviction to be halted. Use the CDC Eviction Moratorium Assistant tool to see if you qualify. If so, the tool produces a customized letter that you can download and print or email directly to your landlord. https://massaccess.suffolklitlab.org/housing/#CDC

REASSESSING OUR NEIGHBORHOOD'S NAME

The Pinckney Neighborhood Association stands with those seeking to end systemic racism. We join the KU and greater Lawrence communities in reiterating that Black Lives Matter.

One way to fulfill this commitment is to reconsider the <u>name</u> of our neighborhood. The Pinckney Neighborhood bears the former name of 6th Street. Until 1912, 6th Street was named Pinckney Street -- although this was not likely the original spelling. Early records from the abolitionist town founders of Lawrence point to the street being named for William Pinkney, the author of an influential anti-slavery document. However, in the late 1800s, maps and newspapers began to use the spelling "Pinckney" (with a 'c'), and by the 1920s for reasons that are still unclear, Lawrence school authorities were formally claiming that the school was named for Charles Cotesworth Pinckney. And so, in circular fashion, Charles Cotesworth Pinckney is now associated with the neighborhood.

Charles Cotesworth Pinckney has no connection to the City of Lawrence or even to the state of Kansas. While he was a Revolutionary War general and a signer of the Constitution, he was also a South Carolina plantation slave-owner who cowrote the Fugitive Slaves Clause. Our neighborhood being associated with someone so profoundly tied to slavery and racism is troubling. Thus, the Neighborhood Association has formed a committee to assess interest in changing the name of our neighborhood. Note: This effort is independent of the elementary school. The Lawrence School Board and USD 497 leadership are conducting their own review of the school's name.

Important General Election Takes Place Nov 3rd ARE YOU REGISTERED TO VOTE?

Double-check that you're registered to vote at https://www.ksvotes.org! If you aren't registered, do so by the deadline of Tuesday, October 13th.

Early voting in Kansas begins October 14th and ends November 2nd. If you plan to vote in-person (whether early or on Election Day), be sure to wear your mask and practice social distancing!

Absentee voting (voting by mail) is available and no excuse is required to receive a ballot by mail in the state of Kansas. Ballots are mailed out beginning 20 days before the election until the 4 days before an election. Make sure you apply for an advance ballot before the deadline of October 13th to receive your ballot in the mail. Fill it out and get it in the mail ASAP, as the Postal Service is experiencing delivery delays. Or, drop off your ballot at one of three drop boxes located at: the Courthouse on Massachusetts St., 2110 Harper St., or 2329 lowa St.
