New Business

Dan Partridge, Director of the Lawrence-Douglas County Health Department, gave us an update on Covid-19 in Lawrence and Douglas County. He said thanks to all of our efforts the infection rate here is much lower than in Kansas as a whole. We currently have a total of 8,804 cases with 222 still active. Cases have been dropping recently in part to the vaccination effort underway since January. Over 50,000 shots have been administered through the efforts of a lot of volunteers. About 150 work to ensure smooth running and over 2,000 people have volunteered to help.
