Chairperson Thellman welcomed everyone, particularly Marcel Harmon and Patrick Kelly who replace Dr. Rick Doll and Stan Rassmussen on the committee.

The meeting notes from the December 8, 2014 meeting were discussed. Motioned by Ackerly and seconded by Harris to approve the December 8, 2014 notes with one minor change adding the words "to approve" in the second paragraph. Motion passed 7-0

**Planning Director Scott McCullough:**

**The North Lawrence Improvement Association would like the following revisions to Horizon 2020:**

**No RS5 zoning in North Lawrence**

**No development in the flood plain or flood way.**

**Current code retained on how much fill can be brought in on a building lot**

**No development on lots less than 7,000 square feet, using RS7 zoning, enabling the property to manage it's own storm water.**

**No apartment, duplex or multi-family zoning**

**Keep Northeast Sector plan intact including Grant Township.**

**Retain all type 1 & 2 soils as agricultural with no development.**

**All of these are requested to control flooding and to prevent another event like the 1993 flood.**
